

Writing News Releases For Your Small Business

News stories or articles about businesses are more widely read and believed than advertisements in newspapers and magazines. Like similar kinds of stories broadcast on radio and television, they are prepared by journalists who are independent of the people or organizations about which they are reporting. This gives news stories more credibility than advertisements, whose paid-for content is, by its nature, biased. The publicity that news stories generate can be more valuable, and contribute more to the image and reputation of your business, than thousands of pounds spent on advertising.

What types of stories get coverage in the news?

Journalists are always on the lookout for newsworthy stories that will be interesting, informative or entertaining to their readers, listeners or viewers.

The most widely used type of news stories are those with 'human interest.' People like to read about what other people are doing. Ideally you should put together a news release that communicates information with this type of human appeal — perhaps involving the activities, achievements or experiences of the people involved in your business, such as customers or employees. Study the types of stories appearing in local newspapers or other media outlets; these will give you ideas for the kind of news you could cover.

How to submit your news release

Check your target publications' websites, or give them a call, to find out if they have particular requirements for the method by which news releases and any accompanying photographs, should be submitted. Some publications will only accept releases by email, fax or hard copy in the mail.

Keep the subject line of your email short and compelling — it needs to grab the reader's attention and make them want to read the rest of the news release.

Don't leave it too late to send your release, particularly if it is publicizing an event or a photo call. Each publication will have a diary of forthcoming events, which it uses to plan the coverage for specific days or weeks.

Try to make your news release timely — give it an angle or a theme that ties it to current events in the news, or to a time of year such as Small Business Saturday or Christmas.

Where to send your news releases

A vital part of publicizing your story is knowing who to send your news release to. Media publications or broadcast outlets normally have different journalists responsible for different interest areas or programs. While some focus on a particular geographic area, others specialize by subject area; for example, education, health, lifestyle or business.

It is a good idea to get to know the local journalists who cover your particular area of expertise, and to build a rapport with them. You can find a full list at http://www.slingshottosuccess.com/press-contacts.html.



five minutes with: Mike Pitt

1. Was there an event or moment in your life when you decided you wanted to own your own business? What was it?

Not exactly. I was planning on doing corporate law and working for a big company. That changed when I started working for O'Neill as an independent sales representative right out of college. It was probably the perfect career for me in that it was an industry I was already credible in and I was able to manage my own program even though ultimately, I had bosses. After about 10 years, I started to look for a new challenge and on a whim, purchased my first small business. That was Castaways, a neighborhood bar in Pleasure Point. The plan was always to keep my "career" and have the other business on the side but by the time I was starting my third "side business", the new direction was pretty clear. I gave up working for O'Neill after 17 years as a sales rep to focus solely on my businesses.

2. What advice would you offer an entrepreneur just starting a business?


Be flexible/adaptive. You encounter so many unforeseen obstacles with all the variables starting a business, it is important to be able to navigate them without being too set on a specific course. There usually isn't just one way to accomplish your goals, there are many. That path tends to evolve along the way.

3. What's the biggest business mistake vou've made and what did vou learn from it?

Underestimating the complexity of it all. What seems to be fairly straight forward in theory tends to always be more difficult in execution. There are so many moving parts that aligning them all the way you want is often easier imagined than in practice.

4. What do you do outside of work that helps you deal with the day to day stress of owning a business?

Surfing has been my sport and therapy of choice since I was 11 years old. It's so ingrained in my life that I rarely even think about it, I just do it. However, I fully recognize it's significance to me and how it helps balance

my entrepreneurial side. Surfing has definitely taught me to be patient. Through surfing I've learned to accept the things I can't change and not to give up on the things I care about and can change.

Candy? Haha. I have no idea. We didn't have much money growing up so I tended to use more creative means to attain the things I really wanted. From a very young age, bartering and salesmanship were my tools. When I really wanted my first surfboard, I traded a Walk-Man I got at the flea market for a bike that was then traded for the surfboard. I remember making that happen. Before that, I'd just show up at home with new items and my mom would have to ask how I got them.


A New Look for Downtown Santa Cruz

After over a year of development, the Downtown Associations is launching a new look and feel for Downtown Santa Cruz.

The new brand which was created by Cosmic Design responds to a comprehensive, community process, in which the Downtown Association strived to reveal a foundation for branding Downtown Santa Cruz. The place-branding process became known as the Downtown Identity Project and included the input of thousands of people.

"We were very impressed with the work (the Downtown Association) had already done when they came to us" Eric Ressler, Cosmic's founder and creative director said of the Downtown Identity Project, "We often work with much larger companies who do not start the process this prepared."

Recognizing the strong ownership and emotional investment that exists within the community for Downtown Santa Cruz, the Downtown Association began the process of rebranding with an extensive outreach and information gathering process.
