If you are part of a couple, keep in mind that you will be together a lot more. If you are single, you may miss the social connections of work. It's best to recognize issues now and learn to adjust to new ways of being.

Ryan recommends you
put that on temporary
hold. Moving is expensive, hard, and a big
adjustment; leaving
a beloved home and
a beloved job at the
same time could be
very difficult.

Make your hobbies pay off – and if you need ideas, start on page 49. Consider working part-time for a temp agency that will

take advantage of your interests and latent skills, or look for a "helper" position that allows flexibility. Open a small business, become a tour guide around town, get a pet, or find a volunteer position with animals; in fact, volunteer anywhere you feel there's a need.

Finally, before you do anything at all, "test-drive first." Try on new tasks. Rent before buying. You'll have a happier retirement when you step carefully.

Two or three decades of not hitting an alarm clock. It's a wonderful thought – for awhile, and then it might be scary. Oddly enough, it seems like leaving the work-world

can be a full-time job in itself, but "Retirement Reinvention" will make it alright.

With most books on retirement, money issues are front-and-center but author Robin Ryan focuses on happiness within financial concerns: you'll absolutely find money advice here, but it's mixed with reminders that your future could be wide open. If it gives you get a burden-off-your-shoulders feeling, all's the better; Ryan is quick to seize that as she throws thought-starters at readers who need to reign in panic and find the silver lining in their golden years.

Readers without a plan will get the most out of "Retirement Reinvention" but there's really something for everyone here. It's easy to understand, quick to read, entertaining, and even forty-somethings will find useful info here. To get the most of your post-work future, a book like this one may be key.



Cash Flow is Your Company's Main Fuel Gauge

Cousing on growth or even profit could lead to trouble. Successful entrepreneurs and small businesses focus on cash flow. With cash in the bank, it might not matter what your profit-and-loss statement looks like, but if you run out of cash, you're like a car that runs out of gas.

A balance sheet that shows rising sales and a healthy bottom line won't mean a thing if you don't have enough cash on hand to pay your bills or payroll. And often, that's exactly what happens. Small businesses simply don't have enough cash on hand to survive when business is good.

Cash In — Cash Out

The way cash flows through your company is what makes cash so important. You start out with some cash in your checking account, with other cash tied up in inventories of raw ingredients, work in progress and finished goods. You sell to customers on credit, so accounts receivable rise to reflect the cash owed to you. When payments arrive, cash flows back into your company, completing the cycle. But is the cycle helping you or hurting you? It depends.

A fast-growing company can quickly and easily out-pace its cash supply. Rising sales might mean

laying out more cash for additional inventory, increased production capacity, more employees and higher sales costs.

Meanwhile, your accounts receivable are also increasing, but you don't expect customers to pay you for 30 days.

It just takes one timing issue and the flow is disrupted!

Stop-and-Go Indicators

Your balance sheet can only tell you whether your company is profitable. It's your cash-flow statement that warns you about running out of cash. If the profit-and-loss statement is your company's speedometer, then the cash-flow statement is its gas gauge. And though it's nice to know how fast you are going, it's far more important to know whether you have the necessary fuel to reach your destination.

Unfortunately, cash-flow statements are not simple to create sometimes. They require you to sort, categorize and make adjustments to numbers on your financial statements. You also have to make some realistic assumptions about future expenses and revenues. But the payoff for this work can be enormous. If projections show that you're about to run out of cash, you can take immediate action to head off the impending crisis.

Maximizing Cash Flow

Once you're equipped to keep a close eye on your company's cash position and future cash needs, you can focus on making sure enough cash is always on hand. The goal is to maximize cash flow, which enables you to take advantage of vendor discounts, pay down debt and add inventory, equipment and people to grow your company.

The first step in maximizing cash is to look at inventory and receivables, which are usually a company's biggest cash drains.

Controlling payables also helps to generate cash. Wait until the due date to pay bills. Some vendors will allow you to stretch another 15 or 30 days if you are an otherwise good customer. Ask for terms on anything you buy; sellers who give terms are providing you with free financing.

All of these steps involve trade-offs — some loss of control or higher operating costs. These costs must be weighed against the benefits of having more cash on hand.

SEO for Small Business: 13 Tips

SEO for Small Business: 13 Tips from Kathy Long, founder of Kat & Mouse

Kathy Long is an internet marketing specialist who has been helping companies boost their Google rankings since the early days of SEO (search engine optimization). A self-taught, self-described "quick learner" who started in the tech industry knowing nothing about computers, Long has since established herself as one of the go-to SEO experts in the San Jose and Santa Cruz areas.

Founder of Kat & Mouse Internet Marketing, Long has a seemingly-endless supply of SEO knowledge and experience to share. I spoke with her about SEO for small business. Here are some of her best tips.

- 1. Put your blog on your website. If you have a blog for your business, make sure it's on your website so all the valuable traffic your content drives goes directly to your site rather than a third-party platform.
- 2. Think about SEO before you build your website. SEO should be part of your website architecture from the very beginning. Before you start building web pages, determine your core offerings and where you want to drive traffic.
- 3. Decide on your silos and categories. Silos are the core offerings of your business and categories are all the offerings within those silos. Long uses the example of Macy's department store to explain this. Macy's silos may be women's clothing, kids' clothing and men's clothing. Categories are blouses, ties, etc. The SEO goal is to focus on your category landing pages because that's how people generally search. Rather than searching "women's clothing," someone is more likely to search "women's Spring blouses."
- 4. Drive traffic to your silos. Drive traffic from your category pages to your silos through links. Long gives the example of a chiropractor who

also offers on-site massage therapy. People will search the phrase "massage in Santa Cruz," so you want to have a silo for massage. Then, whenever the chiropractic page mentions massage, it links to the top-level massage silo page. The more quality links you have directing to the massage page from the other pages, the better. These internal links have SEO power.

- 5. Shorten your URLs. Wordpress, and other content management systems use the title of the web page or blog post as the URL. These can be long and full of words you don't need, such as "and" "with" "the." You can (and should) shorten these URLs to focus on the keywords. For example, the URL for a page or post titled 10 Exercises to Heal Lower Back Pain can be shortened to "Exercises-Lower-Back-Pain."
- 6. Hire an experienced website designer who understands SEO. Your website needs to look good. It also needs to drive traffic. Make sure whoever designs and creates your website has a strong understanding of SEO, marketing, website architecture and using content to drive traffic to your business.
- 7. Know your keywords. How do people search for your products or services? It's not enough to just put up a website. You need to understand who is searching for you and what keywords they're using. Long can help you research the best keywords for your offerings. There are also online keyword and customer research tools, including SEM Rush, Ahrefs and Twinword.
- 8. Create content. Content, which oftentimes takes the form of educational blog posts, is a powerful way to attract your target audience, get people to your website and drive traffic to your silos. Think strategically about using content marketing to strengthen your SEO.
- 9. You don't have to chase the top keywords in your industry. In fact, going for keywords such as "personal injury attorney" is a crowded, competitive market. Long advises instead focusing on aligned keywords, such as "pedestrian accident attorney" or "bicycle accident attorney."
- 10. The longer the article, the better. You want to keep readers engaged. The longer they stay

on your website, the more valuable Google considers the site and it pushes it up higher in search results.

- 11. Establish R.A.P. As Long explains, Google is looking for R.A.P.: relevance, authority and popularity. Relevance means having the right keywords and authority and popularity means having well-written, informative articles that people like and share. These all boost engagement with your audience and Google measures engagement to determine the value of a website.
- 12. Get strategic about your content. As Long says, "Don't write content for content's sake." Instead, craft a smart SEO strategy that includes targeted content, internal links, and website architecture that drives traffic to the core offerings of your business.
- 13. Start thinking about voice search. Voice search is increasingly popular, and it's not going away. Think about how people search using voice, and integrate that into your SEO strategy. When using voice search, people tend to use longer phrases. Where they may type in "thai restaurant Santa Cruz," they may voice search a phrase such as, "What is the best thai restaurant in Santa Cruz, California?"
