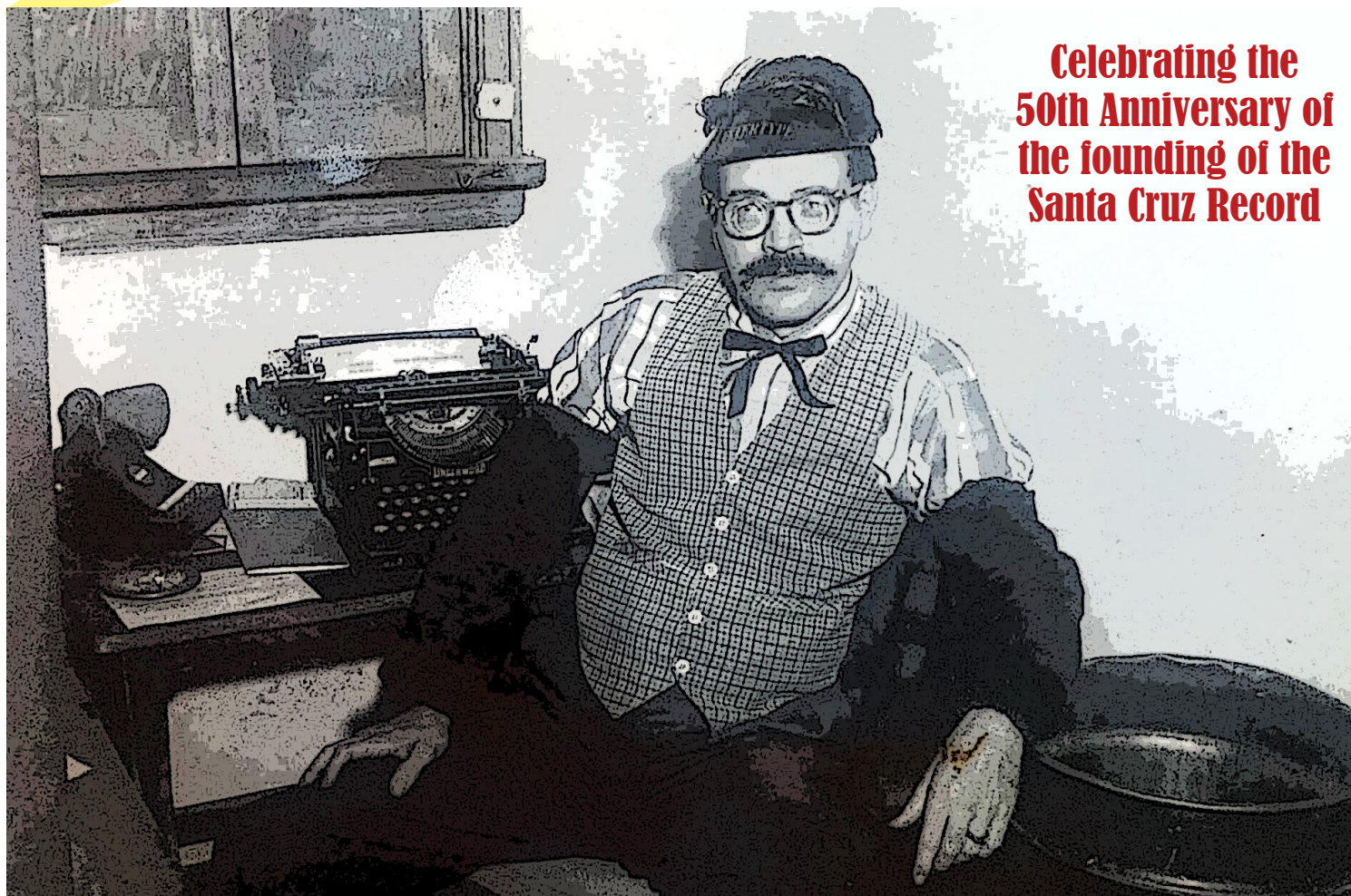

HAPPY 50TH BIRTHDAY SANTA CRUZ RECORD!

Does this gentleman look like a newspaper man, or what?! Meet Barney Barnett, the Founder of the Santa Cruz Record. According to his son Michael, Barney was quite a character. Michael was kind enough to share this story about his father and the early days of the newspaper. Barney was raised by his grandparents, and was especially close to his grandfather Gus Barnett, a WW-1 veteran and railroad man, working in Los Gatos.

Barney was a wiry man, who loved being a newsman and he also loved drinking and socializing at the local bars. He had many friends and had a warm and accepting personality. It seemed everyone knew him, according to his son he was famous, or certainly infamous! He cajoled his way into getting advertising from local watering holes so his drink tab was covered.

Barney would roam the halls of the county building, picking up bits of news and gossip for his fledgling newspaper. He was the courthouse clown, knew everybody, and nobody had a bad word to say. He was friends to judges and lawyers, politicians, printers, other reporters, clerks, barkeeps and bums. Thanks to Barney, the SCR became a "Newspaper of General Circulation" in 1972, which allowed for the publication of Public and Legal Notices, the life blood of the paper. He had to fight against lawyers from the Sentinel and the Pajaronian, who didn't want the competition. This designation required time to build circulation, and readership, and then it had to be adjudicated. Michael and his brothers would sit around the dining table folding papers received back from the printers. Then they would load them into their car and make the journey from Davenport to Watsonville, delivering to the numerous shopkeepers, who all knew him well.



The Santa Cruz Record newspaper was never going to make him rich, but it allowed him to live the life of a newspaperman. He loved everything about the business, but he especially loved the people. At his service after his death in 1984, many of his past courthouse friends came. Gary Patton, then a supervisor for the First District, told a story of Barney falling asleep during a board meeting. The board members skipped the gavel, and filed out the door turning out the light so he could rest there peacefully. "Rest in Peace, Barney Barnett, you were loved by all that knew you and your surviving sons miss you still," says his son Michael.

Many thanks to Michael for sharing this story about his father. I'm grateful that he reached out at this timely moment, and I'm also very grateful that Santa Cruz County business owners, residents and legal offices have chosen the SCR for their publishing needs these past 50 years. Here's to 50 more!

Where You Are is Not Who You Are

by Ursula M. Burns,
former CEO of Xerox

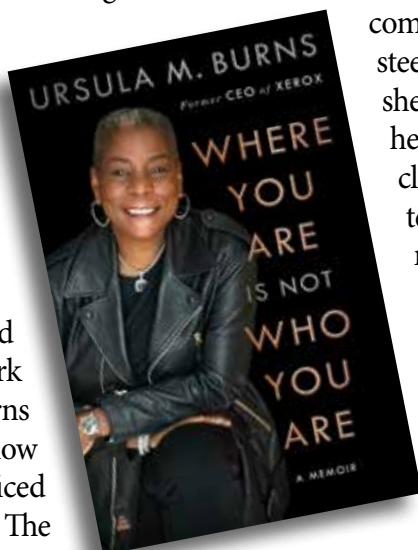


Start small, plan big.

You don't have to have much for the former, just a little love and a place to launch. The latter, though, that takes some work. You have to see the goal, hold your confidence tight, and know yourself well. And then, as in the new book "Where You Are is Not Who You Are" by Ursula M. Burns, you step up and fly.

When she was a child growing up in a New York tenement, Ursula Burns never thought about how much her mother sacrificed for her and her siblings. The family had food, shelter, a TV, school, and clothing. It wasn't until Burns was almost grown that she realized what a feat this was: her single, Panamanian-born mother kept the family going on \$4,400 a year.

Somehow, despite the lack of income, Burns was able to attend a Manhattan Catholic school, where she excelled in her studies and learned that being vocal could make a difference in how things were run. This outspokenness did indeed make change, but it also led to a certain amount of chiding when she was an adult.



Upon graduation, Burns says she had her pick of several major colleges, but she chose Brooklyn Polytech, after having decided upon a career based on the its potential income. It was heavily steeped in math, a skill she was good at but her more-privileged classmates were better; it took a few months to catch up before she began tutoring others in math class. Burns loved school and she was grateful for the help she got from New York's Higher

Education Opportunity Program (HEOP), which provided support, both career-wise and economically.

At the end of her junior year in college, she accepted an internship position at Xerox and the company supported her while she got her master's degree. Upon graduation, she took the full-time job they offered, a position that allowed her to make history...

Get a few pages into "Where You Are is Not Who You Are" and you might reconsider your plans to finish this book. Author Ursula M. Burns jumps almost

immediately to the latter part of her career, leaping from point to place to person in a dizzying chunk that's exhausting to read. Name-dropping features heavily there, it lasts way too long, and it feels forced.

If you're still with the book, you'll be happy when Burns settles in to share her memoir, a rags-to-riches tale that has the feel of a TV movie. It rambles a little, but that rambling is appealing; Burns writes of poverty and of determination, resourcefulness, and the love of family before sliding into the story of her career again.

The second time on that subject, thankfully, is readable and quite well-done.

This is one of those books in which you need to prepare yourself to pick and choose what you read. Be ready to skim or skip parts. Do that, and you'll be fine; otherwise, reading "Where You Are Is Not Who You Are" could be a big task. ■

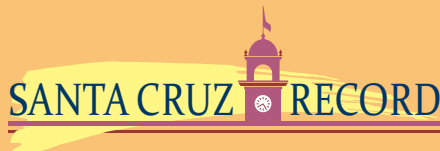

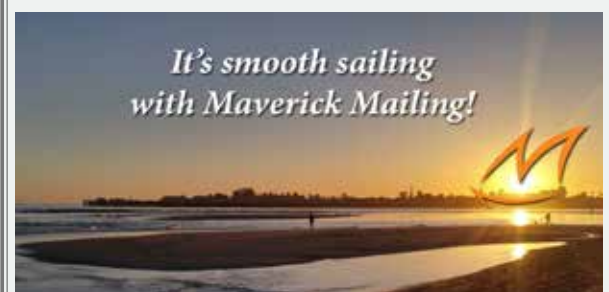
